**Kavous ARDALAN** is a Professor of Finance at the School of Management, Marist College, Poughkeepsie, NY. He holds a PhD in Economics from the University of California, Santa Barbara, USA and a PhD in Finance from York University, Toronto, Ontario, Canada. His research interests are in the theoretical, practical, educational, and philosophical aspects of Finance. He has received four distinguished research awards at national and international conferences. Two of his papers were recognized very highly by the publishers. Three of his papers have been referenced in the *Handbook of Finance*. Internationally, since 2000, he has been consistently ranked as one of the top 23 authors in both finance and economic education. His book is entitled *On the Role of Paradigms in Finance*. **Shmuel N. EISENSTADT** was the Rose Isaacs Professor Emeritus of Sociology at the Hebrew University of Jerusalem, where he served as a faculty member since 1946. He was Chair of the Department of Sociology for 20 years (1949–1969), Dean of the Social Science Faculty (1966–1969), and served in many Hebrew University roles and duties until his retirement in 1983. During his long career Prof. Eisenstadt was a great ambassador of the Hebrew University of Jerusalem. He served as a visiting professor at numerous universities, including Harvard, Stanford, MIT, Chicago, Michigan, Washington, Oslo, Zurich, Vienna, and Hong Kong. He was a Fellow at the Center of Advanced Studies in Behavioral Sciences and the Netherlands Institute of Advanced Studies. As of 1967, Prof. Eisenstadt was a Senior Research Fellow at the Van Leer Institute in Jerusalem. Prof. Eisenstadt was a member of the Israeli Academy of Sciences and Humanities, Foreign Honorary Fellow of the American Academy of Arts and Sciences, Foreign Member of the American Philosophical Society, Foreign Associate of the National Academy of Sciences, Honorary Foreign Research Fellow at the Institute of Sociology of the Chinese Academy of Social Sciences, and Honorary Fellow of the London School of Economics and Political Sciences.

**Leonid GRININ** is a Research Professor and Director of Volgograd Center for Social Research, a co-editor of *Journal of Globalization Studies* and *Social Evolution & History*, co-editor of almanacs *History & Mathematics* and *Evolution*. His current research interests include globalization studies, economic cycles, the long-term trends in the cultural evolution and evolution of technologies, periodization of history, political anthropology and long-term development of political systems. He is author of over 240 scholarly publications, including 18 monographs, e.g., *Philosophy, Sociology, and Theory of History* (2003, 2007), *Productive Forces and Historical Process* (2003, 2006), *The State and Historical Process* (2007, 2009), *Global Crisis in Retrospective. A Brief History of Rises and Crises* (coauthored with A. Korotayev, 2010). **Almas HESHMATI** is a Professor of Economics at the Department of Food and Resource Economics, Korea University, Seoul, South Korea. He was previously Professor of Economics at Seoul National University, University of Kurdistan at Hawler; RATIO Institute, Stockholm; MTT Agrifood Research, Helsinki; Research Fellow at the World Institute for Development Economics Research, The United Nations University (WIDER-UNU), Helsinki; and Associate Professor of Economics at the Stockholm School of Economics. He holds a PhD degree in Economics/Econometrics from the University of Gothenburg. He majors in applied microeconomics and microeconometrics. The focus of his economics research is on the area of agriculture, technology and services, industrial organization, welfare, globalization, and measurement and analysis of performance. In addition to numerous articles, he has published books on global income inequality, Lisbon development strategy, recent developments in the Chinese economy, commercializa-

tion and technology transfer, productivity in East Asian manufacturing, dynamics of industrial revolution, integrated water resources management, development economics infrastructure, information and communication technology industry, and performance in power generation.

**Endre KISS** is a philosopher. He is a Member of the Commission for Future Research of the Hungarian Academy of Sciences and a Professor of the West-Hungarian University, Sopron – Szombathely, as well as the Loránd Eötvös University, Budapest.

**Vladimir V. KLIMENKO** is a Professor, Corresponding Member of the Russian Academy of Sciences, Head of the Global Energy Problems Laboratory, Moscow Power Engineering Institute (Technical University). He is author of 11 books and over 200 papers on thermal physics, energy and environment interactions, climate change, geography and history, including monographs *Climate: Lost Chapter of the World History* (2010), *Cold Climate of the Early Subatlantic Epoch in the Northern Hemisphere* (2004), *Climate of the Medieval Warm Epoch in the Northern Hemisphere* (2001), *Energy, Nature and Climate* (1997).
