The Cycles of Development of Modern World System (2011, in Russian; with A. Korotayev and S. Tsirel); *From Confucius to Comte: The Formation of the Theory, Methodology and Philosophy of History* (2012, in Russian); *Macrohistory and Globalization* (2012); *Cycles, Crises, and Traps of the Modern World-System* (2012, in Russian; with A. Korotayev), as well as *Great Divergence and Great Convergence* (2015, in English; with Andrey Korotayev).
